1. Product Identification

- **Product Name:** Pink Paint – Food Colouring Paint
 - **Product Type:** Alcohol-based edible lacquer paint

2. Product Description

A fast-drying, high-strength edible lacquer paint designed for decorative cake applications. Produces a bright pink gloss finish when applied to suitable surfaces.

3. Intended Use

For decorative use only on dry edible surfaces. Not intended for direct consumption as a standalone product.

4. Composition / Ingredients

- Propylene Glycol (E1520)
- Ethanol (approx. 18%)
- Shellac (E904)
- Carmoisine (E122) *
- Ponceau 4R (E124) *

Additional Warning

- E122 and E124 may have an adverse effect on activity and attention in children

5. Physical & Chemical Properties

- **Appearance:** Pink liquid
 - **Odour:** Characteristic alcohol odour
 - **Solubility:** Soluble in alcohol-based media
 - **Viscosity:** Low to medium (brush able consistency)
 - **Finish:** Gloss
 - **Drying Time:** Approx. 30–60 seconds under ambient conditions

6. Dosage

- Maximum usage level: **2 g/kg** in the final food product, in accordance with applicable food additive regulations

7. Application Guidelines

Surface Preparation

- Apply only to **dry, non-tacky surfaces**, including:
 - Fondant (fully set)
 - Sugar paste / gum paste
 - Royal icing (fully dried)
 - Do not apply to:
 - Wet or freshly iced surfaces
 - High-fat surfaces (unless compatibility is confirmed)

Application Method

- Stir thoroughly before use
 - Apply using a clean, soft brush
 - Build colour using **thin, even layers**
 - Allow each layer to dry before reapplication
 - Avoid over-application to prevent streaking
-

Dilution

- May be diluted with **Rejuvenator Spirit** for lighter tones or fine detail work
-

Cleaning

- Clean brushes and tools using **Matt Paint Cleaner**
 - **Do not clean with water**
-

8. Working Conditions

- **Recommended Temperature:** 18–22°C
 - **Humidity:** Low humidity recommended; high humidity may affect drying and finish
 - Ensure adequate airflow for optimal drying
-

9. Safety Information

- **Flammable** (contains ethanol)
 - Use in a well-ventilated area
 - Keep away from heat, sparks, and open flames
 - Avoid contact with eyes and skin
 - Do not inhale vapours
 - Keep out of reach of children
-

10. Dietary Suitability

- Not suitable for vegetarians or vegans (contains shellac – insect-derived)
 - Not suitable for Halal diets
 - Not suitable for Kosher diets
-

11. Storage Conditions

- Store in a **cool, dry place**
 - Keep away from direct sunlight and heat sources
 - Keep container tightly closed when not in use
-

12. Shelf Life

- **Unopened:** Refer to best before date (typically up to 24 months)
 - **Opened:** Use within a reasonable period; discard if product shows changes in odour, consistency, or performance

13. Regulatory Compliance

- Complies with:
 - **EU Regulation (EC) No 1333/2008** on food additives
 - **EU Regulation (EU) No 1169/2011** on food information to consumers
 - Applicable **UK Food Standards Agency (FSA)** requirements
 - All ingredients are food-grade and used within permitted limits.

14. Limitations

- Not suitable for use on wet or high-moisture surfaces
 - Colour intensity may vary depending on substrate and application method
 - Performance may vary depending on environmental conditions
